Fire Chief and Officers' Reports:

Doug Fritz is looking for an auditor for the Pension fund.

The new State mandated wildfire code is unfunded. Montrose has opted out and Doug thinks that Delta County will do the same.

Doug is hoping that Delta County code enforcement will get the burned house in Lazear torn down. Fire prevention has a \$250K trailer fully equipped with fire prevention education equipment that they would like to take to the Hotchkiss K-8 and possible other schools.

Zack Hotchkiss reports that the house that burned in Hotchkiss is locked up due to the asbestos, and the family can not even go in and get their belongings.

Fires and other calls; 5 lift assists, 1 assisted water rescue., 1 fire alarm malfunction, 2 wildfires, Leroux Creek and South Leroux Creek. Hotchkiss was the support for the those fires.

Fire management aircraft had an emergency landing in Grand Junction. The BLM boxed the fire in well on Monday, and the BLM treated us well. We have a great working relationship. The State was in charge of the fire and the type 3 command center.

Niki Carpenter presented certificates to Doug for the great help that he and his firefighters were to the command center. Niki and Bryant were both on the fire and it was great training for them.

Other responsibilities for the Fire Department was the public safety at the fair rodeo and crowd control.

Equipment: Some of the equipment overheated and Doug would like to get a power washer for the station.

Zack Hotchkiss stated that he will send Doug a link for the radiator

cleaner that he purchased. I works good.

Training: No training this month because the crews were tired from all the fires.

Grants- Doug missed the Safer Grant meeting due to the fires. He will attend the next one. SCBA Grant still has not closed.

Building Maintenance: Doug still needs to get the furnace repaired. Subdivisions: Change in use for the event center on Hwy 133, needs a turning lane. Other, Sheriff Taylor is now on board with the stage 2 restrictions. No outdoor fires of any kind.
