Grants - \$20K owed for Training PPE 7 sets of turnout gear. Safer Grant should pay for part or all of the cost.

Building Maintenance - Doug had the solar system flushed, and he still needs to repair the boiler. He will get that done.

Also discussed was trying to form a Fireman's Auxiliary so that we can have fund raisers to help support the department. Cally suggested speaking to Renee Meredith and Anita Violet. Cathy Chetham of Crawford would for sure be willing to help them get started.

Doug is working with Tami Smith to help her remove some trees from her property. Ron Wheat will do the work. Kathy Welt made a motion that the Fire Department pay Ron Wheat up to \$1200 for that project. Second was made by Ron Prosser and motion carried. Ron Wheats will also be helping Lynette Roberts clear her property. Doug will take firemen up to the clean up so they can get chain saw training. Doug was given a \$5000 hose adapter and he will have to buy the fittings that will work with the new hose that we purchased.
